

物価高騰対策支援給付金

■2024年度住民税非課税世帯に給付金を支給します。

【要件】

次のすべてに当てはまる世帯

- (1)2024年12月13日時点で三田市に住民登録があること
- (2)世帯全員の2024年度住民税均等割が非課税又は免除されている世帯であること(租税条約による免除を除く)
- (3)住民税均等割が課税されている人の扶養親族などのみの世帯ではないこと
- (4)世帯の中に住民税課税となる所得があるのに未申告になっている人がいないこと
- (5)世帯の中に、租税条約による免除の適用を届け出ている人がいないこと
- (6)既に他の自治体で同じ給付を受けていないこと

【支給の方法】

給付の対象になる可能性がある世帯には、1月下旬に「確認書」を送っています。

振込口座が書いてある世帯は手続きはいりません。

振込口座が書いてない世帯は確認書を送り返してください。2025年3月31日必着。

確認書が届いていても対象にならない場合があります。支給の要件を確認してください。

※2024年12月13日より前に、離婚などの原因で扶養関係がなくなっている場合や、2024年12月14日より後に、2024年12月13日より前にさかのぼって三田市に転入届を提出して、お知らせが届いていない場合は、申し出ると給付金を受け取

Benefit Payments to Help with Rising prices

■Households exempt from resident tax for the 2024 fiscal year will receive a cash benefit.

[Requirements]

Households for which all of the following apply:

- (1) Households for those who are registered as residents of Sanda City as of December 13, 2024
- (2) All members of the household must be exempt from the individual resident tax for the 2024 fiscal year or have it waived (excluding exemptions under tax treaties).
- (3) The household does not consist only of dependent relatives, etc., of other individuals that are subject to the fixed portion of resident tax
- (4) The household does not include members that have unreported income that is subject to resident tax
- (5) The household does not include members that have filed a declaration of exemption from tax under a tax treaty
- (6) The household must not have already received the same benefit from another municipality

[How benefit payments will be issued]

Households that may be eligible will have received a confirmation letter in late January.

Households receiving letters with a bank account listed do not need to take any action. Households receiving letters without a bank account listed, need to return the confirmation letter. The application must reach us no later than March 31, 2025.

There are cases where you may be ineligible even if you have received a confirmation letter. Please check the requirements for receiving the benefit payment to see if it applies to you.

*In cases where you are no longer a dependent due to reasons, such as becoming divorced, etc., before December 13, 2024, or cases where you have submitted a move-in notice to Sanda City prior to December 13, 2024, and have not yet received a confirmation letter after December 14, 2024, you still may be eligible to receive the benefit payment if you notify us. 【給付額】

1世帯あたり3万円。※18歳以下の子ども（2006年4月2日以降生まれ）一人あたり2万円の追加。

【給付の時期】

振込口座が書いてある世帯は2025年2月10日振込予定です。

振込口座が書いていない世帯は手続きが完了してから、1か月くらいで、登録した口座にお金を振り込みます。通帳で確認してください。

*The confirmation letter has been sent out based on information that was available on the reference date (December 13, 2024). Depending on whether your tax information has been revised since then, etc., there may be cases where you will be ineligible to receive the benefit payment.

[Benefit payment amount]

30,000 yen per household. *Additional 20,000 yen will be provided for each child under 18 (born on or after April 2, 2006).

[Benefit payment timing]

For households with a bank account listed, the transfer is scheduled for February 10, 2025. For households without a listed bank account, the funds will be transferred to the registered account about one month after the procedures are completed. Please check your bank book to confirm payment.
